Bodleian Libraries

E-Resource Acquisitions & Trials

We are purchasing, over a period of 3 years, access to all modules of Early Arabic Printed Books from the British Library (1475-1900) as part of a Bodleian Libraries wide Gale Accelerate discounted deal.

This year we have been focusing on trialling e-resources in vernacular languages in particular journal and e-book databases:

- · Previously trialled: ArabDigest
- · Recently trialled: Noormags & Noorlibs an Iranian journal and e-book database with a focus on Islamic studies, social sciences and the humanities with texts mostly in Persian but also featuring content in Arabic and English. We have had positive feedback.
- · Current trials: LexiQamus and Wikilala LexiQamus is a well-known dictionary tool to search for Ottoman Turkish words and especially useful for deciphering illegible or unclear words. Wikilala is a discovery portal for Ottoman Turkish printed documents with in built full-text searching tools which allow you to perform searches across the whole corpus.

· Future trials: This term we are hoping also to trial Ottoman related e-resource Muteferriqa as well as Arabic e-books and journal database Al-Manhal.

Donations

We were granted generous permission to select material from the personal library of Professor Wilfred Madelung, author and scholar of early Islamic history and once Laudian Professor of Arabic at Oxford. The donation consists of monographs and journals, mostly in Arabic and English, and includes works on early Islamic history and theology, especially works on Ibadi Islam and a large number of publications from the Institute for Ismaili Studies where he was senior research fellow.

We have received a number of books via Pembroke College Library from the personal library of the late Sir James Craig, British diplomat and ambassador to Syria and Saudi Arabia, who was also a visiting professor in Arabic and lecturer at Pembroke College, 1985–1991. The collection consists mostly of Arabic and English monographs with a focus on Middle Eastern modern history and politics.

We recently received as a bequest the entire personal library of the late Dr Celia Kerslake (1946-2023), lecturer at the University of Oxford and scholar in Turkish studies. Her wonderful collection of Turkish literature and Turkish literary studies will fill some important gaps in our own holdings.

All 3 donations will be catalogued over the coming months and the books added to SOLO.
